POLICY STATEMENT

OBJECTIVES OF THIS POLICY

This policy aims to provide all employees, customers, suppliers, distributors, business contacts, agents, contractors, and members of the public with access to secure channels to report any improper conduct by any member or representative of Nichicon Malaysia. Disclosures will be handled with the utmost confidentiality, and there will be no retaliation or adverse consequences for those who report in good faith.

SCOPE

Improper conduct includes, but is not limited to:

- Any unlawful or illegal activities, whether criminal or breach in civil law;
- Breach of policies and/or procedures;
- Fraud, theft, embezzlement, or dishonesty;
- Corruption/bribery;
- Bullying and harassment;
- Actions that can cause physical danger/harm to another person and/or can give rise to a risk of damage to properties/assets;
- Forgery or alteration of any documents belonging to the Company, customers, or agents of the Company;
- Poor or unethical sales practices, including mis-selling;
- Profiteering as a result of insider knowledge;
- Gross mismanagement or dereliction of duties;
- Conflict of interest;
- Misuse of position or information; and

Any other similar or related irregularities. Any individual aware of or who has reasonable grounds to suspect any improper conduct by an employee or representative of Nichicon Malaysia is encouraged to disclose the available channels.
